### COURSE DESCRIPTION

This course examines, in a comparative fashion, the nature of race and ethnic relations among groups in South Africa and in the United States. It is designed to promote the understanding of the changing dynamics occurring in both societies as they move from systems of formalized racial oppression to open, racially inclusive nations.

We will study social forces and institutions affecting race relations in the two nations. We will examine the notions of "race" and "ethnicity" and explore how they are actualized in both countries. Similarities and differences between the two countries in the construction of race and ethnicity, the development and implementation of social policies, ideologies and sociopolitical systems will be identified.

This course also provides background information and an orientation for students traveling to South Africa as part of the Spring Break study tour. It will give students insights into practical matters for visiting and studying in South Africa, especially at the Nelson Mandela Metropolitan University (NMMU), in Nelson Mandela Metropole (formerly Port Elizabeth), South Africa.

#### **COURSE OBJECTIVES**

- 1. Compare United States and South African race and ethnic relations in a contemporary and historic perspective.
- 2. Provide students an opportunity to observe directly the societal transformation of a country formerly based on racial oppression.
- 3. Familarize students with the Nelson Mandela Metropolitan University -St. Cloud State Study Abroad and Exchange Program

## **COURSE FORMAT**

This course utilizes a lecture - discussion format. Speakers and activities sponsored by campus and community groups, as well as media materials will be used as resources for the course. Guest lecturers may be invited to the class. Students contribute to the learning process by giving oral presentations, and by participating actively.

### **COURSE ASSIGNMENTS**

- 1. Book Review, A Long Walk to Freedom, DUE: February 24, 2016
- 2. Field Work Assignment, March 30. 2016

Over a two-week period observe and record interactions among people in a variety of settings (e.g., school, religious, social, recreational, business) in terms of race and ethnicity

- 3. Final Paper Topic Areas, May 2, 2016: (Select only one area.) This work must use Butler's *Contemporary South Africa* 
  - A. Do a comparison/contrast of aspects of race relations in South Africa and the USA:
    - 1. The legalized system of racial domination used in each society the policies, institutions, laws, social practices and customs used to subjugate racial/ethnic minorities and how they were established
    - 2. The responses of different groups to these conditions What type of movements occurred? What organizations were formed? Under what conditions?
      - a. What were the responses of the racial minority group(s)?
      - b. What were the reactions, positions or responses of the dominant white groups?
    - 3. What were the impacts on the people? The society? Psychological, economic, social?
  - B. Analyze Developments in the Post –Legal (de jure) Oppression Era
    - 1. What attempts are being made or have been made to address the past inequities in each society (e.g., the Truth and Reconciliation Commission in South Africa)
  - C. Examine aspects of institutional and societal life in both societies
    - 1. Culture (e.g., music, dance, film, theater, language)
    - 2. Employment (opportunities, affirmative action)
    - 3. Media (broadcast, print, radio, electronic)
    - 4. Education
    - 5. Health Care
  - D. Examine connections between African Americans in the USA and Black South Africans 1. Schools, Churches, political organizations, music/culture, social justice movements
  - E. Analysis of research on racial/ethnic interactions in the two societies
